## 1040 ENGAGEMENT LETTER

Dear Client,

This letter confirms the terms of our engagement with you and clarifies the nature and extent of services we will provide. We ask all clients for whom returns are prepared to confirm the following arrangement.

### **Individual Income Tax Preparation Services**

We will prepare your 2021 Federal, Vermont and, if specifically requested by you, other state individual income tax returns from information you provide to us. We may ask for clarification of some items, but we will not audit or otherwise verify the data you submit. This engagement is limited to domestic income taxes only and we will not prepare other tax filings that may be required, including but not limited to foreign income tax returns, sales or excise tax filings. Furthermore, if you are subject to state use tax you must inform us of the amount so we can include it in your tax computation. If you identify other required tax filings you may engage us for those items separately, at our discretion.

Our work will not include any procedures to discover defalcations or other irregularities. The only accounting or analysis work we will do is that which is necessary for preparation of your income tax returns.

### **Taxpayer Responsibilities**

It is your responsibility to provide information required for preparation of complete and accurate returns. This includes communicating to us all your income.

You should keep all documents, canceled checks, vehicle mileage logs, charitable acknowledgement letters and other data that support your reported income and deductions. They may be necessary to prove the accuracy and completeness of the returns to a taxing authority. You have the final responsibility for the income tax returns and, therefore, you should review them carefully before you sign them.

### **Filing Deadline**

Please contact us if you would like us to file an extension. The extension only applies to the filing requirement itself and is NOT an extension of the time to pay a tax liability. Therefore, if filing an extension, you should consider making a tax year 2021 payment with the extension to minimize penalties and interest. If applicable, be sure to consider making quarterly estimated payments for the current year, tax year 2022, in accordance with the IRS and state payment schedule.

### **Tax Planning and Audit Representation Services**

We are available throughout the year for consultation, tax planning services and representation in the event your returns are selected for review by the taxing authorities. Such services will be considered a separate engagement.

### **Electronic Filing**

You understand that your income tax returns will be electronically filed through a secured third-party filing service. You may opt out of electronic filing if you so choose.

### **Fee Arrangement and Billing Policy**

Our fee for preparation of your tax returns will be based on the forms and schedules prepared and the amount of time required billed at our standard billing rates. All invoices are due and payable when the preparation of the return is complete.
